# Personal Independence Payment

### About your appeal

Dear

I'm writing to you about your appeal against the Personal Independence Payment decision dated 02 November 2018.

I've looked again at the facts and evidence we used to make the original decision. I've also considered the points you've raised and any new information provided. After careful consideration of all the information, I've changed the original decision, your award will change and your appeal will not continue.

I've considered all the evidence about your conditions and how they affect you as identified in:

- the "How [your] disability affects you" form, and
- the extra information you gave us, and
- the information provided by the health professional consultation report.

I've decided you're still entitled to the Daily Living component of Personal Independence Payment at the Standard rate of £57.30 a week. The period of award is from 02 November 2018 to 14 August 2021 (both dates included).

I've decided you're entitled to the Mobility component of Personal Independence Payment at the Standard rate of £22.65 a week. The period of award is now from 02 November 2018 to 14 August 2021 (both dates included).

Personal Independence Payment is made up of two components, the Daily Living component and the Mobility component. Each component is comprised of two rates, Standard and
