We are intending to publish outputs from our current research projects in due course, once they have been fully designed and delivered. The Department expects to publish all contracted research within 12 weeks of the final report being completed.

The Department published its Areas of Research Interest¹ (ARI) statement in January 2018. This is a high-level summary of DWP's evidence priorities, aimed at an audience of academics and external researchers. The ARI is not exhaustive or prescriptive, but its objective is to enable universities and external organisations to undertake research which addresses DWP's evidence priorities. The Department is undertaking a programme of proactive academic engagement, visiting Universities across the country and using the ARI as a tool to foster new collaborations and conversations with external researchers.
